



1:1 iPad Initiative Update

- After two years of implementation concerns have arisen over whether the goal
 has truly been achieved, or whether our valuable resources and benefits to
 students would be better used elsewhere.
- Admin surveyed freshmen and sophomores along with teachers.
 - Results showed concerns around the iPads and their true benefit.
- Parents shared their concerns over the security of the iPads and what their children were viewing and using them for at home.
- Mr. Shearer consulted with 2 Vocational Schools that also implemented a 1:1 iPad initiative. Both schools shared similar concerns and chose to move away from the initiative

1:1 iPad Initiative: Continued

- New online MCAS testing presented new challenge this year. Collecting and updating iPads was near impossible task to complete.
- We have chosen to move away from this initiative. The result will be:
 - Ability to upgrade our Chromebook inventory for on campus work and future MCAS testing
 - Increase number of Smart Boards on campus
 - Remove liability and security concerns with school equipment leaving campus
 - Save the district approximately \$15,000 annually after these changes and improvements.
